1. Play Area -

2. Defibrillator -
 - ◆ Training to be organised in due course.
 - ◆ Signage to be put in place on the end of the bus shelter and the village hall.
3. Planning applications -
 - ◆ Application PA20/01680 - 1 North Lane, Tregear. Printed copies provided for discussion at meeting of non-material amendment in respect of decision PA19/02461 to allow removal of two roof lights on lower roof, addition of one small window next to porch & render finish between granite & quoins on NE & NW elevations in place of stone. Disappointment expressed regarding the latter.

- ◆ Application PA20/00286 - The Lodge, Penheale Manor, Egloskerry. Circulated between meetings. Listed Building Consent to reconfigure internal stairs and bathroom, & replacement of rear outhouse with pitched canopy roof. Supported.

Clerk to write to Mr Uglow asking for Charity Commission information to facilitate the transfer of the responsibility of the field to the Parish Council.
