The Minutes of the Meeting held on 11 February 2021 were formally and duly approved by the Chairman as a correct record.

4. Pleasure Ground (small field situated in Badharlick) -

Due to the fact that the charity is unworkable in its present state, the Clerk wrote to the sole trustee advising that according to information obtained from the Charity Commission's website it meets the necessary criteria to be able to close it down.

Charities can close if (a) the original purpose has been met or is no longer relevant, (b) there is a lack of funds, and (c) a lack of members. The Charity Commission's

online closure form can be used if the assets are worth less than £100 million and had an income of less than £5 million in its last accounting year.

The transfer of the land to the Parish Council would have to take place before closure of the charity. This should be possible considering that the Parish Council is already the trustee of the turbary ground with the field being managed for the benefit of the whole parish.

The trustee not having accurate information on the whereabouts of the field asked for assistance initially with a field number. Clerk to ask Councillor Burden.

5. Virtual Meetings -

Due to end on the 7 May 2021 unless regulations change. With the Village Hall being not available, a meeting will be scheduled to take place in the Church. Suggested date to be confirmed is Thursday 13 May 2021 (meeting and AGM).
