

Egloskerry Parish Council

Minutes of the Parish Council Meeting held on the 8 November 2018
in Egloskerry Village Hall at 19.30 hours.

Present at Meeting:

Apologies received from: Councillors F Colville & S Sillifant.

Declarations of Interest: Councillor Francis with regard to the Pleasure Ground.

Public participation: Mrs W [redacted] asked if the Parish Council would agree to them having the seat near the bus shelter refurbished and a plaque placed on it in memory of Mr B [redacted] who had helped to raise funds for the village and had started the skittles evening. The cost of this work being paid for by his daughter. A vote was taken and all Councillors unanimously agreed that this was a good idea. It was also agreed that the plaque in recognition of the W.I. be placed on the seat as well. This plaque was passed to Mrs W [redacted] after the meeting. Although welcome to stay, Mrs W [redacted] and Mrs M [redacted] decided to leave the meeting.

The Minutes of the Meeting held on 13 September 2018 were duly approved and signed by the Chairman as a correct record.

Matters Arising from the Minutes:

1. Play Area & Footpaths –
 - The goal posts have rotted out beyond repair. It was suggested they be replaced by posts made of galvanized steel and Mr C Emmet be asked to construct them to a height of 6 feet 6 inches.
 - Email received from Neil Holding of Rural Services advising of an increase in charges of £10 per cut of the Play Area and Footpaths; prices having been unchanged since 2013.
2. Defibrillator -
 - Discussion took place regarding the informative and interesting presentation given by Martin Fagan of Community Heartbeat on 17 October 2018. A vote was taken and it was unanimously agreed to go with his recommendation and have installed the following in the telephone box when it becomes available (likely to be in the Spring). This was proposed by Councillor Burden and seconded by Councillor Paul:-

Zoll AEd 3 - £1400

ShockBox Rotaid u/l heated cabinet - £450

Electrician installation - £200

Signage and safety pack - £50

Training session - £175

Delivery - £50

WebNos Governance system - free

- Clerk to contact Martin Fagan with regard to completing the paperwork.

3. Planning applications – none.
4. Pleasure Ground – a small field situated in Badharlick -
 - Information had been gathered from a local resident who was the Chairman of the Parish Council, and a copy of an agenda dating from the 12 March 1991 included an item ‘Badharlick – Recreation Ground – allotment for the labouring poor’.
 - Rent was collected and 3 members of the Parish council as a committee administered the finance. However over the years and with change of personnel rent was not collected. It is believed that there is a bank account with approximately £300 in it and the intention is for this to become the responsibility of the Parish Council.
 - This parcel of land has been farmed rent free for many years and it was agreed that this arrangement should carry on until further notice.
5. Grass area outside of Penlee, Egloskerry -
 - Resident asked if part of the grass area outside of Penlee could be tarmaced to allow access for a vehicle to park alongside the property. Grass along the front of the bungalow to remain. Deferred from last meeting.
 - The area for discussion lies within the Square. Coincidentally surfacing of the Square was included on the aforementioned agenda dating from the 12 March 1991.
 - The Square is common land and is under the control of the Parish Council. A vote was taken and the Councillors unanimously agreed that the area in question could be surfaced with tarmac to the standard already there.
6. Notice Board (near bus shelter) -
 - Quotes for replacement either obtained from online or from a local resident.
